Dear Member Organisations,

With great honour and excitement, I am sending you this motivation letter for my candidacy as FYEG co-Spokeperson.

In the process of writing this letter, I read the one I sent you last year. This reminded me of the emotion I felt when I decided to run for the FYEG Executive Committee. I lived again through all the passion and enthusiasm I had last time. Although on many occasions the initial enthusiasm fades away with the normal day-to-day of life but my experience in FYEG – the motivation to serve has stayed strong throughout my mandate, and I believe has grown as I got to know the organisation better. When reading those words, I realised the person I was and reflected on the person I am now. During this year, I had the opportunity to experience so much, to meet so many people, to find myself in pleasant and challenging situations. This has all contributed into a very different person: more conscious, more prepared, more mature. Moreover, realising what FYEG effectively does and the potential it has for building a green and radical Europe, has not only kept my passion alive, but has given me more fuel to fight for the green revolution. Therefore, as one might say: **don't stop me now!**

Before becoming an EC member, I was committed to the Green cause in Italy. There, I joined a group of young, competent people, who decided it was time for Italy to have a young political Green group. With these great companions, we founded the Giovani Europeisti Verdi (GEV), now a candidate organisation in FYEG. Being a member of the Executive Committee of a new-born organisation, rising in a political landscape where green politics are struggling, I could learn a lot on how to deal with similar situations and how to support MOs with similar issues and opportunities. Therefore, in this year I have supported MOs in the southern region to facilitate their development through mutual encouragement and collaboration. Everything I learnt from this experience and from all the people I met through this role, coupled with the practical expertise I gained as a member and co-founder of GEV, gave me the right expertise and motivation for both continuing the work with the south and supporting the development of other regional areas or MOs with similar struggles. I, indeed, believe MOs' development is key for our project to advance, and it is the most wonderful way to commence such a green revolution: from the bottom, from the youth.

In this mandate, I have had the opportunity to finally understand what my skills are and how I can use them to give that energy back and fuel our fight. For this, I shall thank the amazing team I had the opportunity to work with, whose spirit I hope I can pass onto the next EC, to allow that great collaboration to be consolidated throughout the years. Due to this support, I realised I am a good team player and networker. I found myself in taking decisions, responsibilities, representing the EC in formal and informal settings, networking with our partners and lobbying for radical ideas. The positive outcomes of these activities showed me these are not only tasks I can do but are tasks I am good at doing. I finally feel I can lead the change and not just observe it.

Being an EC Member has also shown me how this organisation works and how this work can carry on and be improved. In the last year, we have done a great job in developing a strategy for the organisation, which requires continuity and expertise to blossom. I have enjoyed working with the team to develop this strategy and to prioritise our work for the efficient use of our energy. I now realise the central role of such operations and how much time and knowledge this requires to become successful. I would love to be able to keep building on this development as well as actualising the strategy with the skills I have learned during this year.


For all the reasons, I am ever more motivated to use my skills for the improvement of our work, especially in such an unstable political landscape. The concerns about climate and social justice are spiking dramatically. First the health emergency and then the unjustifiable Russian war against Ukraine, are calling for an ever more immediate and unified response. Green politics can be the key for energy independency and solidarity, which are unavoidably linked to a peaceful and reliable Europe. As young greens we must act for this to happen, we must embrace the green fight to spread our ideas. This is not anymore just a matter of politics; I believe we have a duty to act and build together a sustainable, inclusive and solidarist Europe. Therefore, I want to perform this duty to the best of my capacity and use what I learned during my mandate and in my previous political and professional experience to support FYEG. This is why, today I am running for a Co-Spokeperson position. As I am already aware of the difficulties of the role yet also conscious of my skills, I feel I can commit to this position and promise you I will do my best for the development of our Federation and of our green fight.

I hope this letter can demonstrate to you my passion and competences, for giving me your trust to embark in what would be one of the most intense experiences of my life.

Candidacy as Co-Spokeperson of FYEG

The goals of FYEG cannot be achieved in one mandate and cannot be set on the ideas of one person's mind. When thinking about my vision for the Federation, I naturally envisioned the organisational changes and improvements that I believe will be beneficial for pursuing the objectives we will keep deciding on together as a Federation.

I believe we should focus on four main areas for keep being the most kick-ass organisation in Europe!

Creating a structure and network towards 2024

The 2024 European Elections are imminent and the need for a green presence in the European Parliament is ever more necessary. I believe FYEG has the capacity and the potential to empower young greens in this race as well as to build a structure to enable coordinated work towards the elections. Collaboration and knowledge sharing will be a key asset for the positive outcome of the campaign, and that is where our effort should be focused on. In this strategy, FYEG role will be crucial, especially for less structured organisations present in countries where green politics has not blossom yet.

This can only happen if there is a commitment towards three main areas.

- Working with our partners is a necessary part of our commitment for the 2024 campaign. First our relationships with EGP and the Greens/EFA Group will allow us to be more coordinated and visible in different contexts. Moreover, the collaboration with other youth organisations, can allow us to carry on common campaigns, gain political space and develop a sense of unity among youth, which will give young people more possibilities of success. To do so, FYEG needs to carry on being the reliable partner it has proven to be, as well as being present in important events, structures, and conferences. This will allow us not only to network for its own development, but also to create a platform of partners to boost our work and enlarge our audience towards 2024.
- Developing the Young Candidates Platform is also a crucial step for the forthcoming European elections. The Platform is a tool for young green candidates to share knowledge and ideas, as well as for FYEG to follow their campaigns, provide training and support them in their needs. This structure has the potential to create a young European network in the green elections, able to empower also young people with a less strong mother party, becoming instrumental for including young people from underrepresented countries in our Group in the Parliament. I would love to keep on the work that has already commenced on this project and develop the Platform further.

- Finally, I believe advocating for our radical ideas remains our main strength for networking and creating hype towards our activities. The radical politics we put forward has given many young people a home throughout the years. Through our advocacy activities (e.g. resolutions to EGP, the work with the Youth Forum, etc.) we can enhance our politics and attract more committed young people to our cause. This will facilitate the creation of a common understanding towards the 2024 elections. To do so, our campaigning activity in the next two years will be fundamental. The end of 2022 and the beginning of 2023 must be focused on the development of the 2024 EU Elections Campaign, allowing a wide range of young people to understand what a campaign means and to engage in this adventure. I would love to support such a strategic campaign with the skills and knowledge I have developed in my mandate and in my previous experience.

MOs support and capacity building

FYEG is a Federation, which means the Member Organisations are its lifeblood. I believe this should always be our light in the dark, the MOs should always be first in FYEG priorities. To build a sustainable, solidarist and peaceful Europe, we need to spread our voice among the continent. The most powerful way to do so is by empowering the people in every remote corner of Europe. Therefore, being a Federation is the power of our structure. We have the possibility to exchange expertise, to strategize together and to fight for a common cause in a coordinated way. This can only happen if all our MOs are able to blossom, and I believe this is the main responsibility that as EC we should embrace.

For this to happen, I envision two main activities as key for our strategy.

- as EC responsible for structuring the MO Learning Programme (MOLP), I have understood the potentialities of this project and how important this could be for allowing smaller and/or newer MOs to gain confidence and be able to build a sustainable and solid structure. Capacity building of our MOs is key for the development of FYEG and for spreading our green ideas. Therefore, I believe the structure of this programme would be instrumental for such activity and beneficial for a wide set of MOs.
- Enhancing regional and extra-regional coordination and collaboration is also a key activity for reinforcing the capacity of our MOs, as it furthers knowledge sharing and common activities. This could be implemented among MOs with similar structures, for them to share their experiences, concerns and potential solutions, as well as among MOs at different development stages, so they can support each other's with hints and key skills. Such collaboration should be promoted by encouraging common projects and campaigns, as well as creating new moments of exchanges (e.g. MO-to-MO learning programme, MO forum sessions, etc.).

Working for a more strategic and inclusive organisation

The strategic planning to what FYEG has committed throughout the years has allowed for much more efficient work from the organisation. I believe this should be carried on, while expanding to all the areas of our work. I would like to support the creation of a system where individual and common objectives are complementary, and the organisation is therefore able to achieve its goals

not only efficiently but also in a considerate way. Working on the structure will also mean, working on the main areas where FYEG is less experienced, for example towards the inclusion of minorities and racialised groups. FYEG has done great work to become a feminist organisation, I believe this work now should broaden towards even wider inclusion.

In addition to carrying on and refining our strategic planning, I believe we should focus on two main areas to boost and expand the inclusiveness of our organisation.

- First, a policy for more inclusive structures and safe space for different groups should be put in place. Guidelines, infrastructural responses and trainings should be implemented at the Federation level. Moreover, we should support our MOs in this transition, providing all our knowledge and expertise, as well as delivering specific training sessions on inclusiveness and safe space policies, especially for MOs that are struggling more with inclusiveness. The engagement of people from discriminated backgrounds already active within our MOs would be a key asset for this strategy to succeed.
- To understand the struggle of different groups, the organisation should talk to the people who are living this struggle every day. Therefore, I believe the collaboration with organisations that are active in specific context or aim at supporting discriminated or racialised groups, is essential for FYEG. I would like to improve the already existing collaborations and to engage with new organisations.

Enhancing the political discussion

FYEG is a political organisation, and the political debate should always be at the centre of our work. The beauty of our Federation is the heterogeneous character of its members, encompassing many different views of the green spectrum. Therefore, I believe it is crucial for our organisation to create more moments for political discussion. This can enhance more coherence for our work and revitalise our solidity, ever more important in the precarious and evolving political scenario we are living.

Therefore, I feature two aspects we could develop for enhancing the political debate among the Federation.

- First, I believe it is paramount to create further activities specifically aimed at political discussion, besides the ones already existing; online meetings on specific policy areas and or topics could be beneficial for boosting the political debate within the Federation. Whether on a bottom-up basis or from the EC, policy issues deemed in need of further discussion could be proposed and debated in specific meetings. This would allow MOs to achieve a common understanding of the topic, to share ideas in a considerate and structured way and reach mutual solutions.
- The political discussion is also possible during communal projects. Encouraging MOs to work together, in campaigns, resolutions, training activities etc., is instrumental to boost the political debate within the Federation, as this is a natural outcome of the collaboration on specific policy issues.





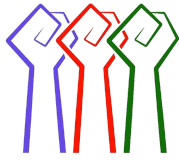
