Switching all of our activities online has been a challenge technically, but most of all mentally. But in those amazing two Executive Committees that I had the pleasure to work in over the last years, we managed. And we did not only manage to keep up the minimum of work, no – I can proudly say that our activism was in some parts even more powerful and kick-ass than ever before. We not only created inspiring safe online spaces where activists could grow close despite of lockdowns, but we also managed to raise our voices even louder by putting up creative online campaigns and protests online and in the streets whenever possible. After those two years, the time that we have all worked for has finally come – we can meet in person again and the outgoing Executive Committee has prepared everything for the upcoming mandate to be absolutely awesome.

Having worked so dedicatedly on FYEGs plans, activities and strategy over the past two years, I now feel ready to step up my game and lead FYEG into the coming period. This is why I am today presenting my candidacy as Co-Spokesperson to you. And even though we can finally meet in person again, the crises we are living through are not stopping but growing by the day. But with my extensive experience within FYEGs structures and the climate movement, I feel well prepared to take on this task and I would be pleased if you would continue to support me over the next year in helping to make FYEG the most empowering feminist climate activist organisation working for real and substantive change.

About me

My name is Clara and I am a feminist climate activist from Germany currently living and studying in the Netherlands. After finishing school, I started with grassroots activism in my home city Dresden, and soon got engaged in the local Young Greens group of which I became a spokesperson. After several years of engagement on local level, I matched my activism with the international character of my studies and joined the International Team of Grüne Jugend while also starting to take part in FYEG events and working groups. In both organisations, I gained a lot of experience in the international coordination of activism, not only on a European level but also globally, as I am convinced that green activism cannot stop at European borders.

My fight for Mental Health, Climate Justice and Intersectional Feminism

It was through the inspiring work of the Feminist Network, where we organised a campaign on sexual consent, that motivated me to join the Executive Committee. For my work there, I set three main priorities: Mental Health, Climate Justice and Intersectional Feminism.

As encouraged by the GA 2020, I started working on a mental health protocol with effective measures to prevent activist burn out within our structures – a topic that has long overshadowed FYEGs work. This past mandate has been the first one for many years, where no EC member had to drop out, so I am very happy to already see the success of this work.

One of my greatest achievements of the past mandate is the successful adoption of a resolution on sexual consent by the Council of the European Green Party, that was handed in by FYEG. This was such an important step because before that resolution, the party had cancelled our cooperation on a campaign on this issue, as there was no official resolution on the matter. This shows again that even in green political structures, feminist positions like consent have to be fought for again and again and I am determined to continue to work on these struggles.

Being responsible for climate topics within the EC, I contributed to our campaigns around the European climate law, energy politics and I had the pleasure to lead the work of FYEG's COP26 delegation. COP26 was one of the most transformative experiences I have had so far, showing me how crucial it is for climate activists and young politicians to be as organised as possible in order to make a difference and lobby decision makers to take decisions in line with the Paris Agreement. Next to learning how to organise one of our most successful campaigns, the work in the COP delegation taught me how valuable cooperation together with the European Green Party and the Green Group in the European Parliament can be to push them to be more radical and at the same time profit from their professional experience and contacts.

My Motivation to be a Co-Spokes

My work and experience on these three topics is precisely what will help me to do a great job as a co-spokesperson that is responsible for communications, the cooperation with the green party and the well-being of our FYEG office as well as the individual EC members. We have done a lot in the past years to make FYEG an even greener, more radical and at the same time more professional organisation, but there is still so much to do.

The elections 2024 are coming up and with every year that climate action gets delayed, creating real change through our democratic rights becomes more important. Never before, FYEG could rely on so professional structures and such a big office. That's why I am super excited to prepare the most captivating election campaign that we have ever seen, with all of you together. Furthermore, I would like to strengthen our influence and activism beyond elections into the work with our partners like the European Green Party or the European Youth Forum, as well as our presence and advocacy at conferences like COP27.

While creating these huge changes and fighting for a healthy planet, we have to make sure that our mental health is always our first priority. We cannot save the world if we don't save our mental health first. Therefore, I am looking forward to make FYEG a leading organisation in activist's mental health by contributing with my work on this topic to the current annual work plan, where all of our study sessions, our summer camp and one of our two big campaigns are centered around mental well-being of change makers.

FYEG has become one of the leading political youth organisations when it comes to queerfeminist policies and structures. We need to make sure that this work continues, but we also have to put our focus now on other types of discrimination like racism that still continues to make our structures inaccessible for many people. As I have done a lot of work on inclusion and fighting ableism, classism and sexism in the EC but also in my previous work in FYEGs Feminist Committee, I am highly motivated to look deeper into racial discrimination and how to tackle it effectively.

I am more than ready for this commitment!

After six years of young green activism, two of them in the EC, I can say that I am motivated to take on a new challenge in the coming term. I now have a great overview over all of our processes, policies and partners. I am super motivated and ready to start right away into a new operational year and together with a new team working on our visions for this organisation and the world. Including the Member Organisations into all of those actions and this growth is a number one priority to me and I am happy to exchange views and ideas with you at any time. I am looking forward to investing 100 percent of my energy and all my heart into this commitment. Therefore, I would be super happy about your support of my candidacy.





MY VISION FOR FYEG

Clara Winkler

The main topics on which I want to focus as Co-Spokes are

1. Making FYEG a Frontrunner in Mental Health
2. Combating Systemic Racism
3. Building Strategic Allyships for Climate Justice

1. Rest is Liberation – Becoming a Frontrunner in Mental Health of Young People

The importance of mental health is still often neglected in organisations that are for a big part run by volunteers. During the pandemic, for the first time, we had the capacity to take a step back, reflect on our current working culture and get help from the outside to start an organisational change process. During this process we looked deep into our structures to figure out why we have seen so many activist burn outs in the recent years and change our working environment into a healthy space. For the first time since a few years, this EC hasn't seen a drop out of a member, which already shows the success of the many different measures we have implemented. This year again, I was responsible for monitoring and evaluating the mental health of our EC and office members. The evaluation showed significant improvements in comparison to the previous year. My vision for FYEG is that we become an organisation where radical self-care becomes part of our working culture, where we always prioritize joy and pleasure within our activism, where everyone feels safe to set boundaries. I am envisioning a space where we acknowledge rest and joy as essential parts of the resistance against the capitalist, exploitative and oppressive system. I want to contribute with my experience to taking the next steps towards that vision by implementing our work plan for 2022 that dedicates all of our educational activities and a campaign to that topic. I am looking forward to coming together with all of you at the FYEG summer camp and other events, to work on that vision together and make it this the much needed reality for all of us.

2. The Future is Intersectional – Doing the Anti-Oppression Work

It is easy to claim to be feminist, but to maintain inherently feminist structures and to do feminist work externally requires hard work and assertiveness. Over the last years, FYEG has done a great job with becoming a feminist organisation and it is extremely important to continue this work. But it is also essential to put a strong focus on other types of discrimination as well, which has not happened

sufficiently within FYEG. The climate movement in Europe is led mostly by white people and organisations like Fridays for Future have been accused of systemic racism. For me, it is important to take this lack of representation of black, indigenous and people of color seriously, to fight racist barriers within FYEGs structures and to help our Member Organisations to make their own structures and work more inclusive and aware of systemic racism. FYEG would profit a lot from building up capacities in that topic where we don't have a lot of expertise yet. We need to constantly improve our internal structures and evaluate how inclusive and accessible our organisation really is. Additionally to breaking down structural barriers, we need to make sure that all of us who are privileged in this system learn how to be strong allies to everyone who faces discrimination.

We have learned from our fight against patriarchy, that to be a truly feminist organisation we not only have to review our internal structures but also clearly speak out on topics of gender discrimination, transphobia and many more to the outside world. Looking at the topics that FYEG has communicated on in the past years, we have done a great job on covering feminist topics but speaking up against racism only takes a small part of our output. My vision is that FYEG takes a clear position against racist injustices in its communications strategy and creates a safe space for black, indigenous and people of color. The fight against discrimination is always intersectional, which should be reflected in all of the work we do and take into account not only sexism and racism but also ableism, classism and all other forms of oppression.

3. Tactics, baby - Building Strategic Allyships for Climate Justice

The crises and struggles that we are currently facing often seem overwhelming for individuals. My experience at COP26 taught me, that only together with the other youth organisations we were able to effectively influence the negotiations and get our demands into final the decision text. I learned that by thinking about strategic partnerships at an early stage of the COP preparations as well as prioritizing them in the other areas where FYEG is active like the Advisory Council on Youth to the Council of Europe, we can have a much bigger impact on the decisions and therefore the realities of so many young people than by working alone. Transformative justice can only be achieved by the collective, by building allyships to complement and inspire each other.

The great thing about FYEG is that we are not only acting in the streets but also in the institutions. During the past years, FYEGs relationship to the European Green Party improved constantly and this cooperation increased our capacities and impact tremendously. By strategically using our position (like we did with the Resolution on Sexual Consent) we can strengthen our position and continue to push EGP towards more radical and progressive policies. We also managed to get a good number of young greens elected into the European Parliament and have a lot of young greens represented in local and national parliaments. Working on spaces for joining forces like the Young Candidates platform or the alumni network we can make sure that no one has to work on issues alone but our efforts are coordinated towards our common goals of limiting the earth overheating at 1.5C and achieving climate justice.

I hope that I could convince you of my motivation and capacities to be FYEG's co-spokesperson. Feel free to reach out with any questions. Looking forward to meeting you soon!
