# MOTIVATION LETTER

ANJA PRESNUKHINA

Dear colleagues!

My name is Anja Presnukhina, I'm a 22-year-old international political organiser and activist from Kirkkonummi, Finland. I am proudly putting my candidacy to become the next Co-Spokesperson of FYEG.

My story with FYEG started at a Finnish Young Greens local event in Hämeenlinna. It was 2019, the European election campaign time. There were a lot of great speakers, but the two who struck me the most were FYEG's then-chairpersons, Katri Ylinen and Zuzana Pavelková. I remember hearing them speaking about the EU's racist and deadly fortress policies, the importance of combating the climate crisis, and above all, the significance of European integration in addressing these challenges. I was 17 then, full of enthusiasm and questions about politics.

Since then, I have interned with the Green Group and FYEG volunteered hundreds of hours in various event and project working groups and served on the executive committee this past year, where my responsibilities included overseeing our Southern European member organizations, starting the process of developing up our strategy for 2025-2030 and assisting the Project Manager with the working on plan for the upcoming year.

Now, with my enthusiasm solidified into a burning passion and an ever-growing list of ideas on how to make our federation stronger, I am willing to give all my resources to the task of being in the steering position of FYEG.

The role of the Co-Spokesperson is a tight mix of interpersonal skills with a clear political vision and the ability to work under big pressure. Co-Spokespeople of FYEG are at the forefront of the organisational and need to be ready to hold themselves accountable. After working in the situations listed below and in my CV, I am certain that this is a role I am ready to take.

As the former Chairperson of the University of Helsinki Greens, I had the privilege of being part of leading the longest university sit-in in Finland's history. This student-led movement sparked a wave of sit-ins across the country, rallying against education cuts and bringing attention to marginalized voices, including the precariat, immigrants, and racialized communities. It was a powerful testament to the impact of collective action, and I do want to bring that to my work in FYEG too.

Professionally, I have worked with both FYEG and the Finnish Young Greens offices, giving me a comprehensive understanding of these organizations. At the moment I work part-time for the educational centre of the Finnish Green Party and sell vintage Moroccan carpets every Saturday. I know the value of a working hour and I am ready to put many of them to the demanding work of the Co-spokes.

As the upcoming mandate of the EC will be short, it will be extremely important to start the work right away. One of the first things that I envision doing as a facilitator of the work of the EC is to build a group work environment based on trust and common goals. We really don't have any time to miss.

# A MOVEMENT THAT KEEPS FIGHTING FOR JOY

## MY VISION FOR THE UPCOMING YEAR IN FYEG

Our federation has grown and developed immensely in the past couple of years, the best examples being the large and diverse volunteer base, our strong presence in the media and the good relationships with the parliamentary group and EGP. In the upcoming 9 months, we must take quick and strategic actions to ensure our success does not fall flat right after the European elections.

To sustain a movement that keeps the fight for joy and against regression, I developed the next three pillars that will guide my work as a co-spokesperson of FYEG.

### **Advocating for Young Greens - from the streets to the cabinets**

Although we, Young Greens have a strong presence within the group and relatively good youth representation in the parliamentary group, we still have to fight for our voices to be heard and taken into account. We are not to be taken for granted or as some souvenirs on the shelf. FYEG needs to take a stronger hold on youth advocacy within the mother parties and all rooms we have access to. The European elections showed that the support that the candidates have from FYEG matters in the national contexts of the parties, and we must not underestimate that.

The shared internships are a good practice that we need to continue with an emphasis on the interns being the rapid messengers of us and the European Parliament.

While advocating for Young Greens, we must not forget our Eastern sister organisation CDN, with which we need to develop a clear strategy on how can we amplify the voices and political messages from Eastern Europe. This work has to be both internally and externally.

### **Fostering effective collaboration with activist movements**

Green parties, as we have them now were born from the grassroots activist movements, and our big asset has always been the connection to the groundwork. Connecting our Green Base with local and international activist movements is a way to create synergy and trust between the organisations.

FYEG consists not only of youth wings of the political parties, but we also have a beautiful amount of civil movements in the Federation. Using our resources to help and emphasize the non-partisan side of our organisation is extremely important if we want to keep being a truly pan-European movement.

### **Strengthening international solidarity through horizontal cooperation and lively ideological debate**

What is a political organisation without real political conversations? Our moderate success in overcoming the struggles of discussing topics like energy transition and Palestine shows us that we really can have brave learning spaces where people and MOs can express their stands and concerns even about the most scared topics.

The Green Base provides us with a great chance to establish more horizontal topical conversations. During the next mandate I am also committed to proactively organise MO to MO trainings on topics that the Federation lacks consensus or knowledge.

## LETTER OF MOTIVATION

My dear friends,

I am thrilled to put myself forward as your next co-spokesperson of FYEG.

In these two pages I want to take the time and share with you who I am and why I am running as your co-spokes.

### My origin story – why am I in politics?

In the process of writing this letter to you, I took the time to read the letter I sent to you over a year ago, when I was running for the position of treasurer on the FYEG executive committee. I relived the emotions I felt when participating in my first FYEG event, when bringing my first activity as a prep-team member to an end and I feel once more how my motivation to be in politics aligns with the space our federation opens up, how they reinforce each other and create something much bigger.

My motivation to be in politics is to relieve this world of injustice, creating a future worth living in, with human rights and protection from any kind of discrimination or marginalization on an individual level and dependable, social, and empowering structures on a communal, societal level.

This motivation is what guides my political engagement and is what I value in the community our federation strives to create.

### My path in FYEG

My path is that of many, always political but not always party-political. I spent a good 10 years being active in international student exchanges, responsible for over 5.000 of them a year. It was only about 5 years ago I decided to step into party-politics and albeit a challenging place to navigate I am ever glad I did. Shortly after I found out and discovered FYEG, a space and a community I find so valuable within a matter of weeks I started dedicating large shares of my capacity to it.

Having acted as prep-team member, written ecosprinter articles, engaged in strategy development, lead working groups, and been part of leading our successful EU electoral campaign team I have gained a thorough, in-depth understanding of our federation. And speaking of federation, one of my goals and core understandings is, that we need to meet and speak with one another if we want to truly be a federation. Therefore I made an effort to do exactly that visiting seven member organizations and speaking individually to many more alone in this mandate. This is a practice I want to mainstream within the EC, ensuring larger connectivity and participation all over Europe.

## Our joint future

Growing together as a federation through communication and connectivity is the first step to a future of FYEG I want to see us work towards. ## The personal is political

My beloved Member Organisations,

It's official. I have decided to run for co-spokesperson of FYEG.

This was not an easy decision to make. I recognise that the past period has not been easy, and my position within FYEG has been complicated. After several months of deliberation and over 40 calls and discussions with many of those dear to me within FYEG and beyond – Member Organisations, active FYEGers, former co-spokespersons, fellow candidates, and friends of FYEG – it is clear to me that my vision is not of one, but of many. It has reinforced my belief that FYEG needs change, and it is this change I want to push for, together.

## A politics of difference as a politics of inclusion

When I first became involved in politics in Europe in 2019 upon moving here, I was often harshly reminded that people like me, racialised and ethnicised communities, do not belong, and that European politics was and continues to be a space of exclusion. Even within progressive spaces, claims of inclusion and intersectionality were not backed by practice. We witness this exclusion across marginalised identities and power imbalances, from the voices of the LGBTQIA+ community, to voices of Southern and Eastern Europe and Balkan communities, to voices of the disabled community.

In finding my role in politics, I was often confronted with Audre Lorde's critique that the master's tools will never dismantle the master's house. Is my being here complicity in systems of oppression?

I deepened my knowledge of decoloniality, of justice, of inclusion, and confronted my own positionality, where the personal as the political could illuminate all my choices. DWARS and later FYEG quickly became a home, as I saw and believed in its potential to change and to become a community for marginalised peoples. Where these spaces and practices were absent, I sought to disrupt and to confront us with our exclusionary realities – our Whiteness, our Westernness, our Eurocentrism – in order to create them.

For 'community must not mean a shedding of our differences, nor the pathetic pretense that these differences do not exist.' For there is no equality, no inclusion, no true community, without the deepest of commitments to embracing difference. This is only possible if we challenge our spaces, confront our realities, and dismantle and recreate our thinkings and practices into one that centralises the differences of marginalised identities as strengths. Only then can we be inclusive and create a community for all.

## A period of reflection: real change?

This process is not easy, and I am not in this alone. However, I had to confront it at its harshest this past year, as the genocide of Palestinians unfolded, facing a reality where racialised and ethnicised peoples are *tolerated* so long as it's within European terms.

I no longer saw European politics as a space where a community including racialised and ethnicised peoples was possible, and was forced to confront an entire shift in my own reality and long-term direction in life.

However, I have also spent a lot of this past period reflecting, learning, and growing, and in that time reflecting on what my involvement in FYEG means and what it should be. There were two stories shared with me that moved me deeply: one on how my criticism of exclusion in Europe and the need for racial justice at the Young Greens Decentralised Trainings inspired someone to write a book on antiracism that sold out; another on how my work on solidarity, justice, and inclusion inspired an MO to believe in change again.

They made me realise the value of my work in bringing forth necessary change, FYEG's potential to still be a home for all, that I get shit done, and that my fight is not over.

They also made me realise our urgent need for creating spaces and dialogues to recognise and understand these different identities, positionalities, and lived experiences in order to embrace them and truly foster community.


## The personal is political

I am fighting for a Europe where 'our personal visions help lay the groundwork for political action.' An FYEG where we deeply realise that the personal is political.

I am running for my community and people like me across Europe. I am running for racialised and ethnicised communities everywhere; for young people from the Global South; for Palestinians, Ukrainians, Armenians, Belarusians, Sudanese, Congolese, the Uyghurs, Rohingya, Kurdish and the Roma, and those fighting and disrupting across the globe.

For we cannot build communities where we don't meaningfully include the many. We have more work to be done and I'm not done yet. Let's fight this fight together and work for a politics for all. Let's get shit done. Not me, us.

The words of John Lewis remind us, racialised and ethnicised youth, LGBTQIA+ youth, disabled youth, youth of the Global South and of Southern and Eastern Europe and the Balkans, youth across marginalised identities and intersections – fellow disruptors, fighters, and changemakers, that change takes time.

*'Ours is not the struggle of one day, one week, or one year. ... Ours is the struggle of a lifetime, or maybe even many lifetimes, and each one of us in every generation must do our part. And if we believe in the change we seek, then it is easy to commit to doing all we can, because the responsibility is ours alone to build a better society and a more peaceful world.'*

These priorities may be ambitious, but we must dream to change, because we care, because we love, because we give a damn. They will not all be achieved in these nine short months, many are an ever ongoing process, so we need an Executive Committee that puts solidarity, justice, and inclusion at the heart of the Federation and ensures their continuance. And I hope you put your trust in me to (co-)lead that push.



As potentially the first non-European racialised and migrantised co-spokesperson, I continue to experience firsthand how exclusionary Europe and European politics are. It has been my highest priority since first being elected to disrupt and confront ourselves with our exclusionary realities – our Whiteness, our Westernness, our Eurocentrism – in order to create spaces and practices for racialised and ethnicised youth. Youth like us deserve to have our voices heard, building our own seat at the table if we have to.

Racialised and ethnicised youth must be able to look at this Federation and find a home. A space where we all actively do our part for inclusion.

Over the past year the RJTF did not just create a strong community and brave space for racialised and ethnicised youth to find support given the challenging times, but we worked hard on an Inclusion Plan to comprehensively address the steps necessary towards a Federation with racial justice at its heart.

As coordinator of the RJTF and someone deeply involved in the drafting process this past year, I am strongly familiar with the plan. Drawing from this familiarity and my own lived experiences, I will prioritise the effective implementation of the Plan this coming period.

Politically, drawing from my academic and personal expertise, I want to further develop our political education and action on decoloniality, continuing where we left off in our first decoloniality resolution.



## 2. Politics of care

*Nothing about us without us as an ethos, not a slogan.*

As we move towards a post-EU elections landscape with redefined capacities, we must, within the best of our capacities, centralise a politics of care. One that isn't just reactive, but proactive and inclusive of the communities most affected by the issues we work on.

This means, for example, including migrants when working on migration, racialised communities when working on racial justice issues, and Eastern Europe when working on Eastern European concerns. This starts from within our broad FYEG family: through the Member Organisations, CDN, the RJTF and BGP, and the Green Base.

We must further actively work towards discussions, planning, and decision-making with intersectionality at its core.

FYEG can further greatly benefit from the expertise of our civil society partners and their already-established networks. The RJTF discussed with the European Network Against Racism possible strategic areas of (long-term) collaboration, and the BGP proposes our involvement in and membership of the International Degrowth Network this coming term. Such partnerships must be explored and pursued further to connect us directly with affected communities in the politics we're doing.

### 3. Politics of solidarity

#### *Building an international movement.*

With the adoption of the resolutions on Palestine, Ukraine, European imperialism, and degrowth, FYEG will have a strong, (re)invigorated mandate to tackle the global crises we face and European complicity in them.

We must therefore keep being vocal and proactive on Palestine and Ukraine, strengthening these efforts as much as we can in light of the ongoing genocides that wages on. We must stand steadfast with the people of Palestine and Ukraine and be loud defenders of international law.

Alongside this, we must realise that European politics impacts the world. FYEG can play a crucial role in educating a young demographic on the crises occurring across the world, and Europe's complicity in them. We need a strong and proactive approach towards political education on, for example, the genocide in Nagorno-Karabakh, the civil war in Sudan, the conflict in Congo and Western Sahara, and Europe's role in them.

We also must strengthen our international cooperation, learning from CDN as a key example. Drawing from the seminars CDN has organised with international partners like the Global Young Greens and Taiwanese Young Greens, and the guests they had of young greens from Africa and Latin America, we too must follow in these footsteps. Through collaborations with such partners, we can learn from and share learnings with them, bring their lived experiences and expertise into our Federation, and build a truly solidary international movement.

## 4. A truly pan-European Federation

### *Expanding capacity-sharing*

As co-spokesperson, it is crucial to me that *all* Member Organisations are equitably represented and their concerns heard, not just the most-established ones. Many of our Member Organisations, particularly those in Central and Eastern Europe, Southern Europe, and the Balkans, have expressed a sense of being neglected or unheard. We must double our efforts to change this.

This includes our political focus, as outlined above, increasing efforts to raise awareness within this Federation and beyond of the issues faced by Member Organisations in underrepresented regions like Azerbaijan, Belarus, Cyprus, Georgia, and Ukraine.

This also includes capacity- and knowledge-sharing initiatives. Our underrepresented Member Organisations are faced with limited capacities, and can benefit most from such support and sharing initiatives from FYEG. I had the opportunity of helping coordinate our first two MO Trainings, and I am familiar with the issues these trainings faced and my own failures to implement long-term support and follow-up. The Inclusion Plan further includes FYEG-MO and MO-MO knowledge-sharing and support facilitation. Such initiatives and improvements to our trainings must be pursued, with the aim of including underrepresented Member Organisations as much as possible.

Where possible, we should also direct capacities towards organising or setting up for future organisation of (informal) knowledge-sharing and resource-compiling initiatives, such as the online seminars CDN organises and the events of the Green Base, with a focus on organisational support as well.

## 5. Avenues of dialogue

### *Revisiting internal structures*

In the many calls and discussions I have had with Member Organisations, it is clear that many, particularly those in Central and Eastern Europe, Southern Europe, and the Balkans, have expressed a sense of being neglected or unheard. Currently, our only major point of input for Member Organisations is once a year at the General Assembly. Consequently, past General Assemblies have been highly tense and mentally-draining. At the same time, we must be aware of the limited capacities of Member Organisations throughout the year for various reasons, and the constantly evolving and changing political priorities of our Member Organisations.

As such, we need to explore ways to effectively communicate to and engage with Member Organisations on political and organisational issues that may be of concern to them. We should explore avenues of dialogue, input-sharing, and collaboration within our capacities – whether one-on-one or in facilitated spaces, and where necessary revisiting the regional calls. Connected to this, Member Organisations need to be able to provide input, have a say, and even criticise the Executive Committee where necessary to facilitate reflection of our work, and to do so they need to be effectively informed of our work.

Within the Executive Committee, the co-spokespersons play a crucial role in working together to foster a space for dialogue. If faced with a similar conflict situation over the coming term, based on the reflections and learnings from the past period individually and as an organisation, I hope to work closely with my fellow co-spokespersons to facilitate a space where we first establish and acknowledge our different positionalities and lived experiences before engaging in sensitive discussions.

The Executive Committee should also (continue to) ensure smooth communication structures between itself and the other bodies of the Federation. As co-spokesperson, I want to devote effort towards identifying areas of improvement in internal communications, not just with Member Organisations, but with the Office, Working Groups, and other FYEG bodies.

# MOTIVATION LETTER

## BEN RYAN

Dear Young European Greens,

I am excited to announce my candidacy for the FYEG Executive Committee 2024/2025 and to outline my ideas for the future of our organisation. My name is Ben Ryan (he/him) and I am a 27 year old Green activist from Ireland, and glad to host you for the 2024 FYEG General Assembly.

I work as a parliamentary assistant to Deputy Patrick Costello, Green Party MP and Spokesperson on Justice, in the Irish Parliament. I have held different roles within the Young Greens Executive Committee over the last 3 years and am currently serving as the Campaigns and Events officer. Additionally I have served almost two years as the Irish Young Greens representative on the National Party Board.

My political journey started with my frustration at the poverty, inequality, and imperialism found throughout the world. I studied a Bachelor of Science Degree in International Development and Food Policy in University College Cork. As part of this degree, I spent 6 months on work placement and lived in a small rural town in Malawi called Nkhata Bay.

I have had the privilege to travel quite widely which has informed a lot of my worldview. I believe that to make serious strides against climate change, we need to tackle poverty, inequality, and imperialism. If people's everyday thoughts are occupied with keeping a roof over their head and food on the table, they won't have the energy to think of the longer-term system changes required to tackle climate change.

After working remotely in Ireland for a year during Covid lockdowns, I felt the need for change and new experiences abroad. I secured an internship with the Green European Journal in Brussels and moved in September 2021.

During the year I worked with the Journal, I quickly became involved with the wider Green family, particularly FYEG, whose offices were only three blocks from mine. Less than two months later I attended my first FYEG event, AlterCOP26 in Glasgow, where I met some of you for the first time. Inspired by all the Young Greens that I met at this event – particularly fellow Irishman Rob O'Donnell – I joined the Irish Young Greens.

The Irish Young Greens at this time were a shadow of what they were in 2019-2020. Divisive debates about the decision of our mother party to go into government, alongside the almost complete shutting down of society due to Covid lockdowns left the organisation on its knees. I was elected the International Officer in November 2021 and used my time in Brussels to develop relationships with Young Greens across Europe. Myself and a handful of others started to re-organise and restarted our membership system, starting again with just a handful of members.

Shortly after moving back to Ireland in September 2022, I was elected Co-Chair and the Irish Young Greens representative on the National Party Board. I continued working with a growing number of committed individuals to rebuild the organisation to the one you see today. I am proud that within two years we have gone from a skeleton organisation to hosting an international young green summer camp, fielding 26 candidates in the recent local elections and now hosting the FYEG General Assembly. Our Young Greens membership has grown to over 420 members.

Over the past three years I may have met you at the several FYEG events such as AlterCOP26 in Glasgow, Young Greens Forum in Brussels, 2022 GA in Karlsruhe, Summer Camp in Podgorica, Mental Health Lab in Brussels, Summer Camp in Rouen or 2023 GA in Barcelona to name a few. I like to think that over time I have contributed a lot to FYEG but also have taken a lot from my involvement. The travels, experiences and people that I have met through FYEG have shaped who I am today. Particularly I would like to note former Sec-Gen Ozgecan Kara who is no longer involved but greatly encouraged me over the last few years.

My professional and personal experiences have equipped me with the political knowledge and capacity to succeed in the role of EC member. I believe that we are in a re-building and re-organising phase after the recent European Elections. Whilst I'm delighted that we went from two Young Green MEPs to the eight we have now, it's clear that Green Politics is on the backfoot in many places.

I want to bring my networks and experience of re-building to help ensure that our MOs are able to learn from each other and build stronger campaigns and electoral representation in the future. I have already helped planning and campaigning in the Irish Local and European elections earlier this and am currently building the campaign to re-elect Patrick at the national election. Additionally I want to help further develop the interoperability and knowledge sharing between MOs through regional organising but also other structures like skills sharing, cross border campaigning and digital communications.

It was my involvement in FYEG that really brought me into the Green family. Through them I joined the Irish Young Greens, then the Irish Green Party, and now work in the parliament and serve on the mother party's board. I want to use the experience, knowledge and networks that I have gained to give back to FYEG and hopefully develop other Young Greens as I once was.

# VISION FOR FYEG BEN RYAN

Dear Young Green comrades,

After a bruising European Parliament campaign, we are now in a much different Europe than we were in only a few months ago. Far-right and fascist forces are gaining much more ground in recent years.

In Ireland, we lost two stellar Green MEPs, Grace O'Sullivan and Ciaran Cuffe, but only by a very small amount. We also lost several MEPS in other established delegations like Germany, France, Finland, Austria and Belgium. However, we really need to celebrate the new MEPs elected from Eastern and Southern members like Latvia, Lithuania, Slovenia and Croatia. Additionally whilst we lost MEPs overall we need to celebrate, and support, our new Young Greens MEPs and work to increase our representation in the coming years.

As a member of the FYEG EC, there are three key things that I want to focus on during my term:

## **Supporting Youth Candidates At All Levels**

We have the highest representation of young MEPs in the European Parliament, and I want to replicate this success across national parties as well. The Irish Young Greens worked to ensure that 20% of our mother Party's candidates were under 35. We are proud to have achieved this goal and of the dedicated campaigns ran by our 26 youth candidates in the Irish local elections. I want to establish a forum for FYEG to examine and learn from the recent successes in national elections in countries like the Netherlands, England, and France, and use the insights of those MOs to build up our youth candidates and strategy for future elections.

The experiences learned from operating the FYEG Young Candidates Platform will further improve youth led electoral strategies. With five years until the next European Elections, we need to focus on growing Green representation at the local, regional, and national levels. My experience as the Youth Rep on my party's Electoral Task Force over the past year has taught me a lot about electoral planning and the importance of supporting candidates to help them achieve the best results. I will bring this experience to FYEG, to help our MOs in elections to come.





# VISION FOR FYEG BEN RYAN

## Enhancing Regional Diversity to Build a Stronger Green Movement

In this mandate, I aim to strengthen our cooperation with member organisations in the South and East regions, working more closely with CDN to develop their capacities and support networks. This is how we can amplify our impact and drive meaningful progress across Europe. Just as we celebrate the increased representation of new voices within our movement, we must also recognize the vital role of smaller EU states in contributing to a more inclusive and dynamic European Green movement. In 2023, the Young Greens of Ireland, Northern Ireland, Scotland, and England & Wales came together to run a summer camp in the north west of Ireland. With 36 young greens from 8 different countries, it was a fantastic opportunity to foster collaboration across regions. I want to see more cross border events organised among MOs and will support them to ensure their success. Strong friendships are key to a more robust and united approach to tackling the climate crisis and promoting social justice.

## Combating Hate and Division Across Europe

Far-right parties have strategically modernised their image over recent years while maintaining radical core policies, leveraging populism to gain legitimacy. Social media and algorithms rewarding outrage/hate has further amplified their reach, with mainstream parties legitimising far-right ideas by adopting their similar policies or even sharing government with them.

While condemning far-right parties for their illiberalism is essential, it is equally important to strengthen democratic awareness and resilience among citizens. We cannot wait for the next European election to start campaigning. I want FYEG to use the next 5 years to educate about the threat of the far-right, about the value of your vote, and the necessity for Kiev and tolerance. By focusing on building an organisation of tolerance, hope, and equality, we can better address and counteract these harmful ideologies. We all have a key role in representing and reinforcing these democratic principles.

If these priorities align with yours, I hope you will trust me with your No.1 Vote.

# MY VISION

I see FYEG primarily as a community, and my Vision is based on how I would like to see our community to evolve during this mandate. This FYEG that I dream of has three main pillars:

FYEG members and MOs tend to be relatively diverse, but it's not enough. We must acknowledge that many categories of people (like immigrants, People of Colour and people with physical disabilities) tend to be underrepresented still today at FYEG, especially in FYEG bodies.

# Motivation letter

Dear Young Greens,

I am Klāvs (he/him) and I am a 22-year-old climate and human rights activist, ecosocialist, and queer from Latvia. In my professional life, I work as a parliamentary assistant in the Parliament of Latvia on environmental and climate policy. For the past mandate as an Executive Committee (EC) member of FYEG, I have been responsible for the Balkan and East member organizations, the Green Rave, and the European Train Tour.

I have been extremely honored to represent FYEG and its member organizations for the past year. Therefore, I will use my motivation letter and vision statement to reflect on my work and outline what I believe should be achieved in the next mandate.

At the start of my mandate, I invited all member organizations I am responsible for to have a call with me to understand their needs and wishes for this mandate. This mandate was highly dominated by the European Parliament elections. However, as the member organizations that I am responsible for are from non-EU countries, I tried to balance their needs and political context with the biggest FYEG European Parliament campaign ever. I ensured that FYEG communicated about, for example, Sakartvelo, Belarus, Ukraine, and Serbia, often in busy communication periods.

My work during this mandate was not limited to our current member organizations. Even before being active in the FYEG as a board member of Protests, the Latvian Young Greens, I developed connections with Estonian Young Greens which materialized into them joining FYEG more than a year later.

Before my candidacy for the FYEG EC last year, I also started developing connections between Protests and the Lithuanian Democrats Youth Wing. Their mother party recently joined the European Green Party (EGP) and just elected their first MEP to the European Parliament. After being elected to the FYEG EC my work with them did not stop. Although I am not responsible for the North region and did not live in Latvia for most of my mandate, I met with them in person twice and kept a close connection with them to help them in their application process for membership in FYEG.

In the regions I am responsible for, I also worked on getting two new member organizations for FYEG in Croatia and Bulgaria. I attended the EGP's fact-finding mission in Croatia to visit the green-left party Možemo before they applied for EGP membership. There I met with the Možemo Youth working group that has been fighting with their mother party to allow them to form an independent youth wing and to join FYEG. I made sure that the Možemo application report to the EGP clearly states that their attitude toward the Možemo Youth working group is unacceptable. Throughout my mandate, I have continued working with the Možemo Youth working group and I am in contact with the EGP to help FYEG gain a progressive and leftist member organization from Croatia.

Likewise, I have also helped the Bulgarian Green Party's youth wing to start setting up a formal organization. I met with them in person and discussed what paths they may take to achieve independence from their mother party. In addition, I kept close contact with them and gave advice when necessary to help them start in the challenging political context. This gave them the basis to work with and led to them establishing a youth wing.

Similarly, I am keeping a close look at the developments in Romania after their progressive, pro-LGBTQIA+ independent incumbent Greens/EFA Member of the European Parliament Nicu got reelected thanks to also massive youth engagement in his campaign and I am hoping that we can soon get a truly progressive Romanian member organization.

My experience and contacts in member organizations and the EGP will be helpful for another mandate. I believe this is important, as the upcoming mandate will be very short, less than a year long. I am ready to start working hard on my vision from day one and to help the new EC members quickly adapt to the very specific work environment in FYEG. Thus, I am kindly asking member organizations to consider supporting me and my vision for FYEG.

In a Europe that continues making fossil fuel deals with authoritarian regimes that violate human rights and commit ethnic cleansing.

As Young Greens, we must continue to be the voice of morality. We must hold our mother parties and the group accountable to ensure that they do not fuck us over in compromises. Now that the Greens will be in the leading coalition in the EU, we must tirelessly push for things that matter to us. But we can only do that successfully if FYEG remains strong, united, and deeply connected to our member organizations.

## **The expansion of influence from underrepresented regions and FYEG in the Greens**

Even though we lost seats in the European Parliament, we must also be happy about the wins we gained. We won in Denmark. We expanded to the East and South and gained representation in Croatia, Slovenia, Lithuania, and Latvia. We kept a seat in Romania despite the difficult circumstances. We got three young candidates from the FYEG Young Candidates Platform elected, including the outgoing co-spokesperson of FYEG Benni. However, the existing power dynamics in the Greens still do not acknowledge this change in regional balance. For example, both leading candidates were from Western Europe, while Southern and Eastern European candidates also ran.

We will have a new role in the upcoming European Parliament mandate. That gives us better chances than ever to push for things that matter to us by working together with the Greens/EFA group. However, we have seen in several member organizations that their mother party being in power often means compromising on our core values. Thus, if elected for the following mandate, I would ensure that we continue to lobby for things that we want to change by constructively working with the EGP and Group. While being critical of political compromises that are unacceptable to us, e.g., on human rights, climate, biodiversity, youth, or migrants' rights.

# Vision statement

---

## The expansion of FYEG

FYEG still lacks member organizations from several countries. During my mandate, I have pushed forward the process to expand FYEG. However, this process requires much longer time than just one mandate. If I were elected for another mandate, I would continue my work on our potential member organizations in the North, South, and Balkan regions.

I see major prospects in Denmark, and Lithuania, where we already have established organizations that are connected to their mother parties. While in many other countries, we have Green parties and youth organizations that are slowly gaining ground. And then we have parties that are explicitly blocking any chances of their youth wings being established although they have a group of young people fighting for that. There is no simple solution to solve all of those issues that young greens face. But if elected, I would continue working with the region responsible to help our potential member organizations grow closer to FYEG.

## FYEG, which works with member organizations and partners

Member organizations and our sister organization CDN are extremely important to FYEG. This mandate allowed me to understand our long-term systematic problems in our engagement with our Eastern member organizations and CDN. In the upcoming mandate, we must set up long-term plans for proactively working with these organizations, while respecting their often lower capacities and higher burnout risk. At the core of this plan must be the organizations themselves, as they are the most aware of their needs and capacities. During the EC task assignment, the responsibility over the Eastern MOs must be assigned as a higher capacity job than it was until now. We must change our working style with CDN, which is extremely important for raising their and our member organization capacities and publicity. I believe that our current collaboration has been quite distant from CDN, although we started working on bringing us closer in the later part of this mandate.

At the same time, we must ensure that our member organizations are truly progressive and green. FYEG member organizations have many different opinions on many issues, as political contexts are widely different from Lisbon to Baku. Yet we have a distinct ideology that puts people, climate, and equality first. I find it deeply upsetting that we have a candidate member organization that is self-proclaiming going against the woke ideology or puts in its statutes after joining FYEG that they support a marriage between only a man and a woman and Christian values. I believe such organizations have no place in the FYEG family.

**The GA in Barcelona made me fall in love with the community that is FYEG. It's diversity, it's wish to want to change the Europe for the better and in it's differences.**


**I knew from then on that I will want to actively be part of that change.**

# Renzo Gort

It's my honour to present myself as a candidate for the executive committee of FYEG. It has only been about a year ago that I had my first experience with this beautiful organisation, but it feels like forever already. I've met so many lovely people from all over Europe and I hope I can do my part in helping our movement.

## **A bit about me**

For the people who don't me yet, I am Renzo, I am 21 years old and live in Hoorn, a small city in the north-west of the Netherlands. I love reading books, listening to music, taking walks in nature (I should do it more often) and most of all to paint my hair. During the day I work as a web-developer at a small company which develops software to inspect all kinds of items.

It has only been 3 years since I really came in contact with politics. That was at the general elections of 2021. It was the first time I was allowed to vote and also the first time I really looked in to what politics is and what it means. Before 2021 I never really thought of that. Back home we don't really talk about politics, and growing up in a town meant that the views that I was subjected to weren't exactly left-wing. Luckily it was still quite liberal, but because of where I grew up I know how easy it can be to believe in the things the right and far-right are saying. It was completely normal to like things like 'zwarte piet' (blackface), and politicians like Mark Rutte and Geert Wilders.

This is exactly what motivates me, making left and green values normal again. We can probably all see it, the values of the people who vote for right wing parties aren't necessarily the same as the far-right. I think that often they are even more aligned with ours than we sometimes think. I see it in my friends or family members, while they have often quite liberal values, they are often stuck in the narratives of the right. That's why I like that we did focus on migration last election, not to repeat their narrative, but to counter it with our own.








## Young Greens

Most of the experience I have is within the Dutch young greens, DWARS. I became a member 2,5 years ago and have since done numerous things. I have been a board member of the local DWARS Amsterdam chapter and have been active in multiple committees. I have also done things within FYEG, but I will come to that a bit later.

My first 'real' experience was in the local board of DWARS Amsterdam. There, as board member politics, I helped with the organisation of multiple activities. Back then it was all still quite new, but I learned quite a lot in that year. While attending the meetings of the GroenLinks Amsterdam group, I saw the struggles between being idealistic and being in a coalition with other parties. While often the council members wanted more, it was sometimes just not possible. At the same time you only see the things that have been agreed on in the media and the reactions to it on social media. I think we can do more against this image, by communicating better what we think, even if that isn't what has been agreed upon. By explaining what we did and why we did it, I think we can take away a bit of the frustration of defending something you actually also wanted to see differently.

One example where this was also visible was with a new proposal on the regulation of rental rooms in the city. In that proposal, the requirement that each renter should get their own individual rental agreement was scrapped. Meaning that renters could get into problems when their roommates have problems, like not being able to pay the rent. With this proposal we, DWARS Amsterdam, worked together with the local student unions to keep the requirement, together with some other things. After we made a statement together and lobbied via different routes, the requirement was not scrapped.





After a year in Amsterdam, I was secretary of two national committees. The first one is the international activities committee where, as the name suggests, we organise international activities. I think this one is quite relevant for what we do with FYEG. You can see that the prices for things like food and places to sleep keep rising. Making organising a trip abroad sometimes more difficult than you would like. One other thing that I noticed is that communications with local young greens can sometimes be a bit hard. I see a role here for FYEG, not that we need to do those communications, but rather build such a network of young greens that it becomes easy to be in contact.

The second committee is the topic-based economics committee (see this more as like a working group, but we also have working groups which are different in nature making it hard to find the right word, ugh..). In this committee we discuss the current events, make articles, organise activities, and make amendments for political platforms or manifestos. Last year we were lucky by having two elections and a update of our own DWARS political platform, meaning we have made amendments to those platforms all year long. It's interesting to see how words have so much meaning, write the same point in different words and it has a different weight. It's something to keep in mind, while discussing current events or making amendments, but especially while making amendments or resolutions about controversial topics. It's hard to find a balance to using strong wording and respecting other viewpoints. It's something to keep in mind, for example while discussing topics like Palestine or Ukraine. I see it as a job for all of us, to keep reminding ourselves and each other of the fact that we are all human beings. Be kind to each other. <3

### **Young European Greens**

I promised to talk a bit about the experiences within FYEG, and here it is. This experience is one of the key reasons I am writing this motivation at all. Working together with all of you during the last campaign was something I will not easily forget. I value the support given from the office and EC while working in our different teams. I definitely think it is something we should continue doing. I have viewed the Green Base as a place where we connect and work together, apart from our collective Discord struggles.





As a team leader of the digital organising team (or digital campaigning team, I aren't sure which one it is till this date) I helped with the digital actions that we did, together with our lovely volunteers. The first petition on the rights of women and LGBTQIA+ migrants, asylum seekers and refugees was a lot of figuring out what to do and how to do it. But I think we have learned a lot from it, which helped with the actions that we did after that. I thank the office and the EC, in special Vita and Sean, for the awesome working together. I think here especially about the email action to ban arms exports to Israel, in which we sent more than 1100 emails to Ursula von der Leyen, wishing her that the email finds her horribly. The discussions on what to include, within the framework set out by the EC, and which tone we would use in the texts was nice, civil, and constructive. I think this is 1 of the best examples on how we can work together on topics with a high emotional charge, even if we don't agree on everything.

### **What should we be?**

This leads me to the final part of this motivation, what should we be? I think we fulfil multiple roles as a European political youth organisation. It's a place where we can all come together, online and psychically. We learn from each others experiences and have the greatest amounts of fun. Next to that we have the political part. We lobby within our mother party and try to work together, but we also try to lobby outside of our party. We work together with other organisations to form alliances, making statements and pressure the status quo from the inside and outside. We make our own statements based on the things that we find important and with our own narrative. At last we have our people. We provide education, internships and jobs. With those we can provide amazing opportunities and learning experiences. We try to get our own young candidates elected, and work together to make our voice heard.

But this is not enough. I think that seeing it as separate parts is not enough. The parts don't work without each other. By becoming a even bigger and more active community, it gets more inviting to do political stuff. By having young people in parliaments we create the representation that is needed for other people to put themselves forward as candidates. It's all dependent on each other, which is lovely and scary at the same time.





How do you end these things really? Anyway, I hope you have been able to get to know me a bit better, about what motivates me, about what my experience are, and how I connect those to our beautiful organisation. Feel free to contact me for any questions, even if they are just about my favourite books or who I think is the best artist.

Hello, and welcome to my vision for FYEG. It's not complete, and it shouldn't be as it is merely my own thoughts. I'm hoping to expand on it in the coming year, working together with everyone, so feel free to reach out :))

## **Solidarity on all levels**

One of our most important values is solidarity. Solidarity with each other and those in other parts of the world. We learn from one another's viewpoints and arguments, and use those experiences to adapt and improve our own. This way we inspire each other to always stand for that what is right.

I think this viewpoint is the corner stone of our European organisation, we try to look further than our own national borders. Yet, it is also difficult. It is hard to determine what to focus on. Sometimes it is hard to learn from others before you need to make a statement. Despite this, I think that FYEG can be the organisation that always thinks of and with others to adapt our stances on all kinds of topics. Where it is the norm to reach out to Southern and Eastern MOs and enable our MOs to do the same. Yet we also should take into account the capacity of our underrepresented and smaller MOs. It would be good to setup a structure that incentivize communication between the EC and MOs on political topics, preferably on a frequent but low demanding way.

## **Communication, understanding and transparency**

One of the things that is really important is communications. Without it we are useless, because if nobody knows what we do, we are standing alone. We are already doing a great job with Instagram where we post regularly about a diverse range of topics. One thing I would add is more cooperation with our MOs to get more reach and visibility to our members. But there is more than Instagram, we have started really using emails, with the building of lists through email actions and petitions. This is something I would continue as it is going quite well.





Something I would like to add to our communications is more internal communications. Communications about the lobby to EGP, what we are doing on certain topics, and what things are happening within FYEG. Certain things are confidential and can therefore not be communicated, however we can look into ways in which we can share what we are lobbying on and with which intends. Because if we don't communicate on our lobby, our members don't know that we are doing it. By communicating on it, members feel included and can even reach out if they have valuable knowledge on the topic, strengthening our arguments. With this we shouldn't be scared to publicly criticize our mother party, not by kicking them to the ground but by providing our view on current events or strategies.

## **Community**

The last pillar in this vision is our community. They have shown up in the previous two pillars, and with good reason. Without our members we are nowhere. Like we have done in the EU24 campaign we can use our community to expand the things that we can do. We gather new ideas, energy and knowledge. That's why I liked that we have setup the Green Base, which we should continue and make an integral part of FYEG. In the Green Base we should look into ways we can spark more discussions on all topics, to a degree where it is weird if certain news or events aren't shared there.

The Green Base creates an opportunity for more members to be actively engaged with FYEG, even if they don't have a lot of time. One thing we should watch out for is the fact that bonding online can be hard, so we should put extra energy into including everyone in the conversations.

One last part of our community is getting people inside FYEG. Too often I notice within my own MO that people maybe know that FYEG exists, but not what we do or how they can become active. I think it would be good to promote our working groups more as they are now not really that visible. Next to that I would love to see some more working groups so we have more places where members can become active and do something that interests them. With that I would also like to see that it becomes more accessible to join the working groups, by for example not requiring a whole application phase, but just a few questions to see if you are a member and what your contact details are.

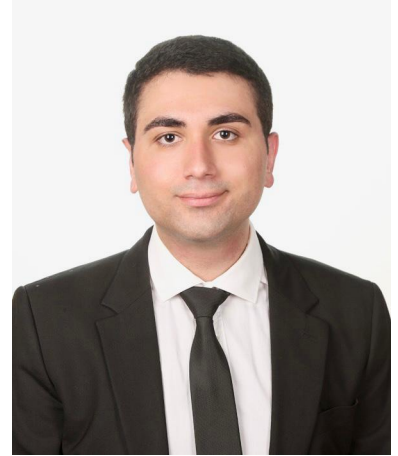

I applied for membership during the formation of the working group and became one of its first members, and we have been working together ever since. Then I started my legal internship and became a lawyer in 2021. I am currently pursuing my master's thesis on Climate Justice and Climate Migration at Istanbul Medeniyet University. I am also doing a master's degree in International Relations at Eötvös Loránd University. I finished my first year as the top student of the university with 5 out of 5 in all classes and I also worked as a teaching assistant at the Eötvös Loránd University Institute of Political and International

Studies and next year I will write my master's thesis on Climate Diplomacy. Also, for the next semester, I have been accepted for an Erasmus at Heidelberg University, which will facilitate my participation in meetings in Brussels if elected.

I have been a part of various organizations until today, but FYEG was the first organization where I felt at home. I have never seen a place where young people from so many different backgrounds and countries work so devotedly for a common cause, look out for each other and make great friendships. Thanks to FYEG, I also have made great friends, participated in amazing events and gained incredible experiences. I am a candidate because I want to make all this even better and make FYEG a youth organization that everyone wants to be a part of.

As we have seen in the recent European Parliament elections, the Green forces from Western Europe are being succeeded by Central and Eastern European ones. One of the biggest reasons for this is the voting preferences of young people. I want to maintain this trend and at the same time increase the declining support in Western Europe. For example, during my studies in Hungary, I talked to young people and tried to involve them in FYEG. If I am elected, one of my first goals will be to see that at the next General Assembly we vote for Hungarian youth to join us together with their organizations.

These are not my only objectives, but the main ones:

- 1) Strive to increase youth participation and grow FYEG and its member organizations in each country.

- 3) Protecting the Green Deal and pushing politicians to ensure we meet the 2030 and 2050 targets in the next five critical years.

# Motivation letter

**Dear Young greens,**

My name is Tom, I am a 24-years-old disabled green activist, from France. I've spent years fighting for environmental, social and inclusive justice with les Jeunes Écologistes and les Écologistes (ex-EELV), in popular education as one of pedagogy officers where I personally took part in more than 180 interventions in schools, universities, prisons or third places in the Young Europeans and also anti-ableism movements.

Now, I have decided to take it a step further by being a candidate for the Executive Committee of FYEG. Throughout the years and different experiences, I developed skills to help my political family. Getting involved in Green politics was natural for me, coming from the countryside, I saw the destruction of our ecosystem due to chemicals and human constructions. As I was born in Brittany I grew up with a cultural particularism, a language and history that really differ from France. It was easy to choose a political family who put cultural diversity at the heart of their project. As a trade union member, I can be proud to be in organisations that put social justice as a core value, defending the most precarious against injustice and the 1%. I'm proud to be part of a political family that listened to me and made sure I was heard as a disabled activist, and finally a family who does not step back an inch in our relentless fight against the far right, on a daily basis with the Jeunes Écologistes.

I have the will and the experience to help make the FYEG our common home, today many of the members either do not know about the FYEG or so little. We have a duty to educate them about what the FYEG can bring them, from tools to formation or even opportunities. For example, I stumbled and learnt about the FYEG after years in the Jeunes écologistes, we have to make sure that every single new member in a member organisation knows about the FYEG when they join and

can be an active part of our federation, it could be done with a digital booklet that is sent whenever someone joins a MO or with more frequent “welcoming” meetings.

We cannot claim to be 'welcoming' or 'benevolent' as long as disabled people struggle to get involved in our organisations or remain excluded. While 87 million Europeans are disabled, we have to create a working group on disability and anti-ableism which will be the spearhead to push forward policies with our MO and MEP. Today disabled people are still excluded from politics, more than 800 000 disabled people were barred from participating in elections, and there are legal restrictions in 7 countries that put a stop to their participation. We need to address the lack of disabled activists in the different spheres of powers and by addressing the lack of representation we will then be able to lead campaigns against the discriminative policies across Europe: the stérilisation of disabled womxn, the lack of work safety and many others.

We are all facing common struggles, and each of our experiences can be of help to other people across Europe, from fundings to mobilisation and coordinating european-wide campaigns. My mandate would also be a mandate of preparation, preparation as an organisation against the continuous and ongoing assault of the far right and right against our rights, our values and sometimes even our identities or lives. We have to strengthen our federation against the fascist threat, and create a common narrative of progressive and clear values. We need to develop our network with partners: NGOs, Unions, the civil society as a whole to keep our feet on the ground, we cannot afford to stay in our bubble. Some of our member organisations already have experience with these topics, the FYEG is the right platform to have transnational training on actions, tools.

Europe is at a turning point: the far-right is still getting stronger and stronger, the right is radicalising, and the liberals are contributing to the climatic, social catastrophe we are all heading towards. As we saw in France with the New

Popular Front, the youth is politicised and eager to join organisations when they have a proper political project that contributes to a fairer society. Together we can defeat the far right, and push it back all across Europe.

I cannot stress enough that I will fight with all my energy to push for a more ambitious organisation that speaks for all and that works for all, the FYEG as the resources to be even more successful.

I think it's time for me to give back to the green family everything it gave me, from friends, to opportunities and for helping me grow.

# Motivation Letter

Name: Andrej Zlatović

Subject: Candidacy for Treasurer

Growing up in the Western Balkans, in a country that was under sanctions and bombed, has permanently changed the way me and people from my region see the world. This has even affected my family, allowing me to grow up in a very antifascist and anti-authoritarian household, where I realised the necessity of political struggle against oppression very early on. During my life I have faced discrimination because of my mixed Serbian and Croatian heritage, because of questioning of gender norms through my appearance and expression, and due to my openly leftist political views. With my story being one of many such examples, amplifying the unique worldview of people coming from the Balkans and Eastern Europe will only aid us in disentangling the current geopolitical situations we are facing. We, as those who have had conflicts on our mind since childhood, need to make sure these mistakes are not repeated. Once our experiences are represented and critically discussed in a safe environment, conversations will naturally move in more fruitful and reconciliatory directions. This is especially important considering the pressing issues of the war in Ukraine and the invasion of Gaza, bellicose right-wing politicians and the neo-colonialism of the Global South.

It was not until I found the green movement, that I was able to feel comfortable within a community of people. In this regard, FYEG, which forms the backbone of our movement, has the power to foster that diverse community for so many people, like it did for me. This has materialized at many of the events I've participated in and helped facilitate, as well as during my role on the campaign team. All of this was only possible due to the privilege I had to be able to afford time off to attend events and volunteer, as well as find money for transport and participation fees. While promoting FYEG with other volunteers of the Green Youth of Serbia, I have often found that money was at the forefront of their worries when deciding whether to participate. This has culminated in this decision to run for EC, specifically to be Treasurer for the next mandate, to address the issues many of our members are facing.

Despite my social sciences background, economics and statistics are fields I have been involved with, whether it was conducting statistical analyses on the effect COVID-19 had on household income or doing budget analyses with NGOs for multi-year projects. Additional activist experiences, such as working in food banks, or with children of marginalized backgrounds in impoverished areas, have allowed me to address the issues of poverty and homelessness, and these are the topics I always try to come back to in my work. While FYEG works within a different kind of field than organisations I worked with before, economic privilege continually dictates who is, and who is not able to participate in activism and politics. We must address the financial differences of Eastern and Western MOs and find ways to make sure that all feel equal in the spaces we create and this I aim to do as your Treasurer. Additionally, despite these glaring economic inequalities, I know we can strive towards more representation and to create more accessible spaces for those with disabilities. If elected as Treasurer, the EC will be able to have a more balanced outlook with crucial context from a non-EU/EEA perspective. Since economic differences can manifest themselves in many forms, from the ability to commit to a timeline of long-term volunteering, to even coming to this very general assembly, we should have a perspective that more accurately represents the median European.

Relying on my experiences from the campaign team of FYEG which included both direct work with volunteers, as well as digital organizing, I am aware of my capabilities in both front facing roles as well as in capacity building, and this is experience I plan on using when budgeting. Additionally, in my role as co-spokesperson of Green Youth of Serbia, I always prioritised member growth and retention, managing to take an organisation of 9 members to now over 90 members, making it the largest opposition political party youth organisation in Serbia. In this role I have also created yearly budgets and reports, both for our organisation and for three successful projects done in the past year. Alongside this, I regularly had meetings and coordinated with the presidency and general secretary of our mother party, the Green-Left Front, submitting requests when necessary and ensuring that those requests are reported on afterwards.

As your Treasurer, cooperation with the FYEG office will come naturally and enable us to optimally allocate our budget, while also ensuring the necessary level of transparency that an organization such as FYEG should provide. Working on capacity building and forming a strong network of volunteers in multiple countries will assuredly benefit our fundraising efforts and establish easier access to grants and donations, which is a clear and efficient strategy to ensure that organizational funds will not be an issue.

I hope that in this letter I was able to convey my dedication and expertise in order to take on this daunting role. I aim to help FYEG develop in this new term, which has developed after the European Parliament elections and the best way for me to do so would be through work with our finance team. Within our green family we can reach our united goal of a solidary, inclusive Europe. It would be my honor if you gave me your trust to be your Treasurer and present your voices and ideas in this decisive year.

# Vision for FYEG

Name: Andrej Zlatović

Subject: Candidacy for Treasurer

**Let our network speak for itself:** In order to best support our member organisations (MOs) we need to know their needs and problems. Only with direct communication with our MOs can we ensure that we are able to properly provide assistance, and that our efforts are properly focused. In this manner, FYEG often lags behind the Cooperation and Development Network (CDN) when it comes to the relationship between MOs and their umbrella organisations. With proper coordination, we can better learn from the practices of CDN. Only with proper communication can we accordingly address the monetary needs of our network and set proper goals and priorities. As treasurer, I will make sure that executive committee (EC) members have the funds for MO visits, and that, when possible, increased time commitment and initiative from MOs is stimulated with project and grant proposals. More oral communication with well-recorded minutes will ensure increased cohesion and representation within FYEG. These steps will also ensure that our MOs feel heard and that their members are able to express their opinions.

**FYEG as a network and facilitator for our MOs:** Many of our MOs face daily issues due to a lack of skills that are necessary for any modern organisation. We must find ways to address issues that MOs deal with, and there is a myriad of ways to do this while not overburdening event organisers too much. One clear method is for FYEG to facilitate cross-organisational trainings on topics such as regionalism and representation, social media, or budget management. Because within our network of MOs there is a bevy of experience, we can engage those that have successfully solved these issues to share their knowledge with representatives from other MOs which are currently struggling. Our future treasurer, aside from knowing how to spend funds, needs to keep in mind how to achieve our goals by sometimes avoiding unnecessary costs and burdening staff. In this way, FYEG will be more represented outside of the in-person events and annual General Assemblies to the whole network with minimal financial requirements and time commitment, while also strengthening inter MO relationships.



### **An accountable voice from an underrepresented MO and region:**

With my past work as co-spokesperson of the Green Youth of Serbia and role in the campaign team, I have systematically been an accountable team player, making sure all tasks are done on time, while also striving whenever possible to speak about the issues of under representation. The Balkans have slowly started fostering a home for the Green idea due to the emphasis it places on reconciliation, ecology, pacifism and feminism in a region that has too often lacked political options which champion these ideas. If we are able to systematically support and finance green movements in this region, I know there is significant potential to spread our network in **Croatia, Bosnia and Herzegovina, Bulgaria and Kosovo**, while supporting our current MOs in Albania, Greece, Montenegro, North Macedonia and Türkiye. This will lead to breaking the stigma that the Balkans as a region usually face, and will help us foster a stronger atmosphere of cooperation and reconciliation within FYEG.

**One euro is not worth the same everywhere:** When discussing differences and privilege, we too rarely comment on the economic inequalities. While people in Germany are earning a median 3500 euros per month, the median salary in Serbia is a measly 630 euros. Additionally, as studies have repeatedly shown, financial struggles disproportionately affect people from underprivileged backgrounds, such as women, migrants, racial and ethnic minorities and people with disabilities. We will not be socially equal while we are economically unequal. We must observe the reality of economic inequalities, and account for them at our events, making sure they are maximally accessible for all. We have to strive toward a more decentralized approach to offering funding and grants. This also applies when we determine participation fees or which participants can have their travel costs covered in advance, while making sure that they do not feel shame due to requesting support. Having a non-EU/EEA perspective when allocating finances is necessary in order to achieve a more accurate picture of Europe within our network.

**More activities to supplement statements - activism, to strengthen politics:** While we have the visibility of a political party youth organization, our status as an autonomous non-government organisation gives us much more power and potential when performing actions, as well as the ability to work with Civil Society Organisations. When spreading the Green idea, we have the freedom to do actions which a lot of our MOs cannot. Therefore, we should liberally take activism as part of our development strategy and keep this in mind also when budgeting and fundraising. We too often lean into the comfort of the statement, neglecting the value of direct action as a way of showcasing dissatisfaction through civil disobedience of the capitalist regime. We must have one leg in institutions and the other on the streets. Especially for organisations working within authoritarian systems (such as the one I come from), as well as those currently facing active invasions or occupations such as Georgia and Ukraine, typical political engagement will not bear fruit in the same manner as in Western democracies and this should be reflected in our financial plan. We need to strive for a way to enable those in underrepresented positions, to voice their struggles, and continue their fight against authoritarianism, war and all forms of oppression.

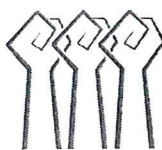

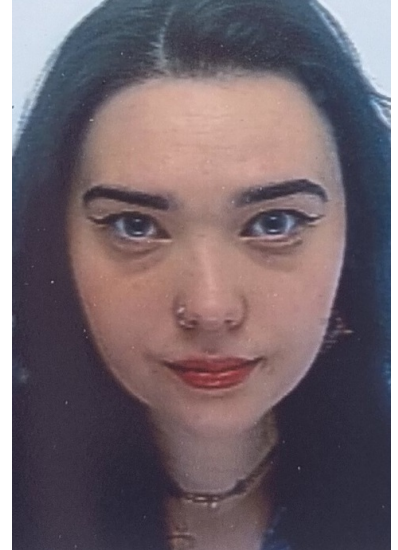

Dear FYEG,

My name is Lovisa Claesson (she/her) and I am a Swedish climate justice and human rights activist from Sweden, currently based in the Netherlands. In this letter, I will explain why I am delighted at the prospect of becoming your next treasurer.

My experience in Green politics started in 2016, when I, as a nervous, but motivated, 13-year old, entered my first meeting of Grön Ungdom. Despite my age, I quickly felt at home in this movement, assuming numerous roles in the organization throughout the years. My fondest memories include being the spokesperson of Grön Ungdom in Stockholm and a member of our international committee.

In recent years, I've left Sweden for Germany and the Netherlands. There, I found new homes in both Grüne Jugend and DWARS. Moreover, it has given me the motivation to finally become active in an organization I have heard about ever since my first encounters with Grön Ungdom - FYEG. After attending my first FYEG event as a Swedish delegate at the General Assembly in 2022, I instantly fell in love with the organization. I believe that my background in a membership organization with a strong organizational tradition will help me in this role. After my years in Grön Ungdom, I have a long experience of overseeing administrative formalities, IRPs, and budgetary matters, interests I have also brought to previous FYEG General Assemblies. I have similar administrative experiences from other forms of NGO work, such as an association at my high school that organized a festival for about 200 students. As president of the association, I managed our finances and accounting, increased our fundings, and established formal bank contacts for the association. Moreover, my work in the Ecosprinter Editorial Board has given me valuable insights in FYEG and pan-European organizing.
