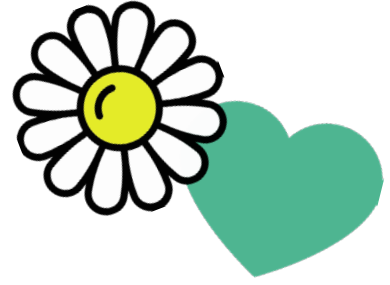

## General Assembly

The Federation of Young European Greens

Dear General Assembly,

With this letter, I am expressing my interest in becoming a member of the Ecosprinter Editorial Board. Since 2019, I have been a member of the Belarusian Young Greens, an associate member organization of the Federation of Young European Greens (FYEG). That same year, I was introduced to FYEG and I am grateful that our paths have continued to align.

Unfortunately, the events of 2020, when elections in Belarus were once again falsified and activists were persecuted, forced me to leave my homeland. The onset of Russia's full-scale war in Ukraine has further delayed any hopes of a swift return. My heart aches, as do the hearts of many in similar situations: approximately 500,000 Belarusians were forced to leave the country, at least 1,415 people (as of July 4, 2024) are imprisoned for their fight against dictatorship, and in Ukraine, people die daily because of Russian aggression, aided by the Lukashenka regime.

I want to restore hope that this situation will change. I wish to draw the attention of many Europeans to the hardships faced by people in our region. I believe I can achieve this through a medium that is natural for me — writing. This is why I am applying for this position.

Beyond the experience listed in my resume, I have extensive experience working with texts. I have written publications for the Cooperation and Development Network Eastern Europe, translated content for top Belarusian YouTube channels (such as *życio-malina* with 100,000 subscribers), and worked as an audio transcriptionist. In February 2024, I was selected to participate in a literary residency at Dom Kultury Śródmieście in Warsaw. Currently, I work for two independent Belarusian media organizations, where I write grant applications and reports — skills I am ready to bring to the Ecosprinter Editorial Board.

Additionally, I have a significant social capital network consisting of various Belarusian journalists, and I am well-acquainted with many journalists and authors from Ukraine and the region as a whole. I am prepared to develop the magazine and contribute my Belarusian and Eastern European perspectives, which I believe are currently underrepresented within the Federation of Young European Greens. This representation is crucial not only for me but for all people from Eastern Europe.

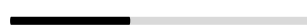
